# Terms & Conditions

- MINIMUM OPENING ORDERS OF \$100 WHICH MUST BE PAID IN FULL PRIOR TO SHIPPING
- MINIMUM REORDERS OF \$75
- ALLOW 10-15 BUSINESS DAYS FOR ORDERS TO BE PROCESSED AND FILLED (EXCLUDES SHIPPING)
- RUSH SERVICE IS AVAILABLE, PLEASE INQUIRE AT TIME OF ORDERING

FIRST ORDERS MUST BE PAID IN FULL BY CHECK TO PEACH PRESS & CHECKS MUST CLEAR PRIOR TO SHIPPING. INVOICE WILL BE SENT BY EMAIL UPON SHIPMENT. ALL ORDERS MUST BE PAID 15 DAYS FROM DATE SHIPPED. A PENALTY OF 5% OF ORDER TOTAL WILL BE ADDED FOR ORDERS EVERY 15 DAYS PAST DUE. SHIPPING: FOB LOS ANGELES, CALIFORNIA VIA USPS OR UPS GROUND, CUSTOMERS PAY SHIPPING. ANY CLAIMS FOR DAMAGE/ MIS-SHIPED ITEMS MUST BE MADE WITHIN 5 BUSINESS DAYS OF PRODUCT RECEIPT. THE BUYER IS REQUIRED TO DOCUMENT NON-CONFORMANCE AND EMAIL A REQUEST FOR EXCHANGE WHICH MAY/MAY NOT BE GRANTED BY PEACH PRESS. EXCHANGES OTHER THAN FOR DAMAGED/MIS-SHIPED ITEMS (I.E. COLOR/PRINT VARIATION DUE TO THE NATURE OF LETTERPRESS PRINTING) WILL NOT BE ACCEPTED. IN THE EVENT OF DELAYS CAUSED BY FACTORS BEYOND OUR CONTROL, OR NONPERFORMANCE, THE BUYER AGREES TO INDEMNIFY, DEFEND AND HOLD PEACH PRESS HARMLESS FROM ANY COSTS OR DAMAGES THAT MAY RESULT. BUYER SHALL INCUR ALL COSTS ALLOWED BY LAW IN ORDER TO ENFORCE PEACH PRESS TERMS AND CONDITIONS.
